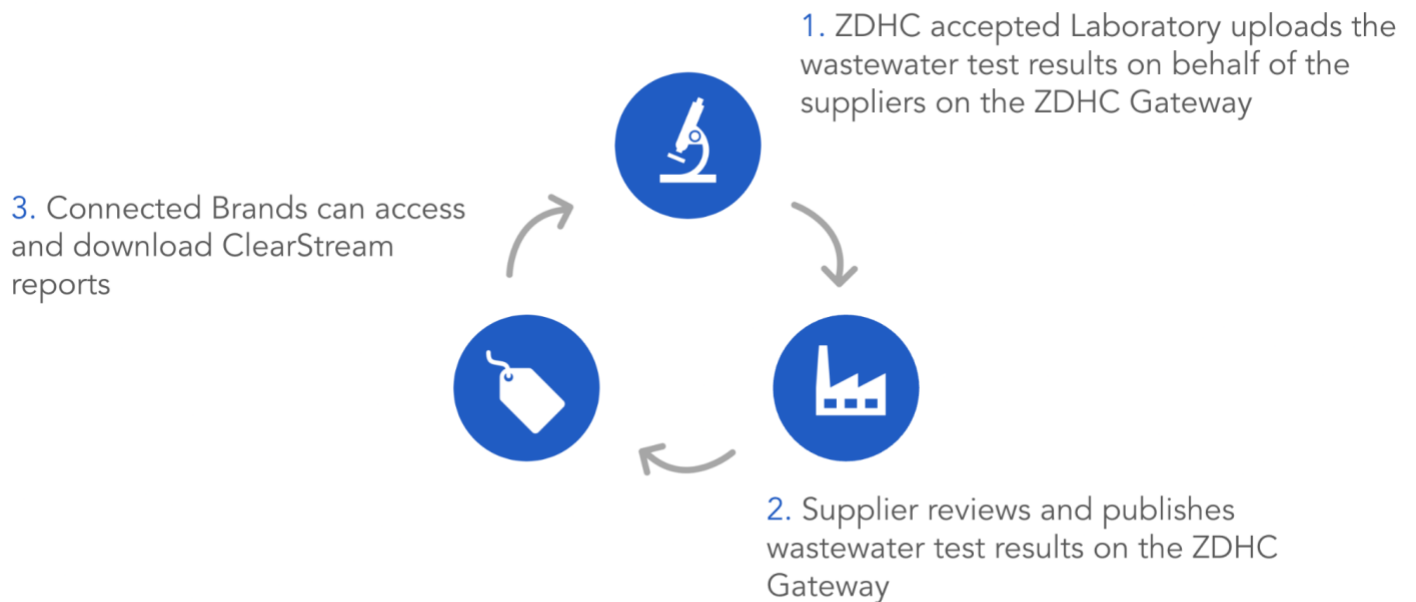




# Gateway Pricing Wastewater Reporting Suppliers / ZDHC accepted Laboratories 2023

The ZDHC Gateway - Wastewater Module saves time and supports transparency throughout the value chain. Through the ZDHC Gateway Wastewater Module, suppliers can share their wastewater test results simultaneously with all of their clients (connected Brands).

## How to get started ?

### Wastewater reporting fee

Before [ZDHC accepted Laboratories](#) can upload wastewater test results on the ZDHC Gateway on behalf of a supplier, the supplier needs to make sure the wastewater reporting fee is paid and their wastewater reporting subscription is active. The wastewater reporting fee can be paid by the supplier or by the ZDHC accepted laboratory who conducted the wastewater testing for them.


The wastewater reporting fee is **250 Euros** per year and is active for 12 months on the date of payment. Throughout the active subscription, more wastewater test reports can be uploaded. It is recommended to do so at least twice a year in April and October as outlined in the [ZDHC Wastewater Guidelines](#).

### Example 1

Supplier ZYX has paid the wastewater reporting fee of 250 Euros on 15th March 2023 on the ZDHC Gateway. The supplier is eligible to accept and publish wastewater test reports, uploaded by a ZDHC accepted Laboratory until 14th March 2024. On 15th March the supplier or the ZDHC accepted Laboratory on behalf of the supplier, will need to renew the wastewater reporting subscription.

### Example 2:

A ZDHC accepted Laboratory has paid the wastewater reporting fee of 250 Euros on 15th March 2023 for Supplier XYZ and activated the Wastewater Reporting Subscription for the supplier in their ZDHC Gateway account. The ZDHC accepted Laboratory is now eligible to upload wastewater test reports conducted in line with the Wastewater Guidelines on the ZDHC Gateway until 14th March 2024. On 15th March 2024 the ZDHC accepted Laboratory will need to renew the Wastewater Reporting Subscription for another year to be able to upload new wastewater test reports.
